**CANCELLATIONS:**

All fees will be refunded in full if cancellation occurs more than two weeks prior to scheduled hire. A 50% refund will be given if cancellation occurs in the week prior to the scheduled hire. If cancellation occurs after the vehicle is on site, or in transit, a refund of 50% of hire charge will apply.

**PERIOD OF HIRE:**

The period of hire shall commence from the time that the vehicle is unlocked and made ready for transportation to the nominated site, and shall cease at the time that the hirer grants access to the **North MRA** for the purposes of locking the vehicle for return transport.

**TRANSPORT:**

Transport arrangements are the hirers responsibility. The transport company/person will have to provide the **North MRA** with a certificate of currency regarding their cover of insurance. The transport company/person will have to liase with **North MRA**, a minimum of five working days before pickup, as to what connections for lights/brakes will be required for the prime mover.

**ASSEMBLY/DISSASSEMBLY:**

A fee of \$120.00 applies to all vehicle hirings. A standard excess of \$1000.00 applies unless the hirer provides proof of insurance to cover all possibilities.

The hirer will be charged for the cost of of any repairs/fines etc incurred whilst in their possession of hiring the vehicle.

**(A verbal/pencil booking shall not apply unless in writing on the official hire form)**

**NORTH MRA RESERVES THE RIGHT TO RE-LET THE STAGE IF THE BOND IS NOT PAID IN THE STIPULATED TIME.** *Bond will be returned/subtracted on return of clean undamaged vehicle , or on cancellation.*
